LOW-EMITTING MATERIALS

The use of ceramic tiles in internal areas of buildings helps reduce the presence of air contaminants which compromise the comfort and wellbeing of installation staff, occupants and the environment.

Emilgroup ceramic tiles **do not give off VOC** (volatile organic substances) as they are mineral-based finish flooring products without integral organic-based coatings and sealants.

As set by LEED, they qualify for credit without any testing requirements.
